FinCrime.com is sponsored by a network of state bankers associations, and is open to their member financial institutions and law enforcement. Participating financial institutions in FinCrime share information in an online, searchable database of fraudulent activity. The result-shared aggregate data identifies and links criminals to their acts. FinCrime's focus is to improve financial institutions' ability to detect and prevent fraud losses and to assist law enforcement in the prosecution of criminals.

FinCrime.com provides a communication vehicle for financial institutions and law enforcement, functioning as a clearinghouse of information. Participants submit fraud data into a central depository which immediately notifies the participating users via email. This early awareness allows you to take action to prevent fraud losses in your bank.

The shared database provides opportunities to build larger "multi-bank" cases out of smaller individual losses, helping financial institutions and law enforcement focus on repeat offenders and organized crime. Through this effort, we hope to gain overall loss reduction for State Banking Association members as professional criminals will find financial institution fraud more difficult, more risky and less profitable to pursue!

Thumbprint Signature Program

Reduce Check Fraud

Montana financial institutions began using a new security device in 1998, the Thumbprint Signature Pad. The touch pad is intended to deter counterfeit and stolen check fraud by obtaining a Thumbprint Signature (fingerprint) from **non-customers** (customers who do not have a depository relationship with the bank) when cashing “on-us” and “not-on-us” checks.

The thumbprints can be used by law enforcement agencies in the investigation of fraud claims made by account holders, and bank’s usage of the program is a natural deterrent.

Criminals seeking to commit check fraud are unlikely to put their thumbprints on bogus checks.
